

MIKE MORGAN - WAUWATOSA CITY COUNCIL 7TH DISTRICT (R)

Key findings include:

- **Profile & Tenure:** Mike Morgan has served two terms on the Wauwatosa Common Council (first elected in 2020, reelected in 2024), running unopposed in both elections. He represented District 7 and is now running for District 11.
- **Community-Facing Image:** Morgan presents himself as a longtime Wauwatosa community member, youth sports organizer, and school district event staffer, with deep ties to local athletics and civic groups.
- **Consistent Right-Wing Political Alignment:** Morgan has donated multiple times to local Republican Party committees and follows and interacts with pro-Trump and MAGA-aligned accounts, including figures who promote election denial narratives.
- **Engagement With Election Denial Content:** Morgan has interacted with accounts and posts promoting false claims that the 2020 election was rigged or included illegal votes, and he has echoed rhetoric suggesting “DNC fraud of 2020.”
- **Hardline Immigration / ICE Rhetoric:** Morgan has interacted with and amplified posts attacking critics of ICE and framing immigration enforcement in culture-war terms, including insulting public figures who oppose ICE activity.
- **Use and Amplification of Homophobic and Transphobic Content:** Morgan has interacted with posts using slurs and derogatory language about LGBTQ+ people, including mocking public figures, trans people, and gay men.
- **Racialized Attacks on Black Public Officials:** Morgan has interacted with posts attacking **Ketanji Brown Jackson** and **Karine Jean-Pierre** using racially coded, derogatory rhetoric, contributing to online harassment narratives targeting prominent Black women in public office.
- **History of Inflammatory Social Media Behavior:** Past reporting documented Morgan minimizing COVID-19 and January 6, attacking LGBTQ+ rights as “propaganda,” using racially charged language toward public officials, and posting content he later claimed was “satire.” Some posts were later deleted after media scrutiny.
- **Pattern of Hostile Rhetoric Toward Democrats:** Morgan has repeatedly used insulting language to attack Democratic leaders and public officials, including personal attacks on President Biden and Democratic appointees.

Wauwatosa is the oldest municipality in Milwaukee with about 47,700 people; majority White (79%), with smaller but growing Black (7%), Asian (4–5%), and Hispanic/Latino (5%) populations [[Census Reporter](#), accessed, 11/10/2025]. Politically Wauwatosa is a democratic stronghold, the city clerk’s page shows county’s Biden-heavy margin 66% to Trump’s 31.9%, so you can characterize Wauwatosa as a reliably Democratic municipal electorate even though the state was close [[Wauwatosa City](#), 11/4/2020].

Also in the 2024 presidential election, Kamala Harris carried Wauwatosa with 69.0% to Donald Trump’s 29.0% [[Js Online](#), 4/2/2024] [Wauwatosa City, 11/5/2024]. Wauwatosa wasn’t a center for 2020-style “stop the steal” activity, but it’s part of the Milwaukee-area election system that has been under extra scrutiny from state-level election-denier figures. That’s the same environment where former Milwaukee deputy election director Kimberly Zapata was convicted in 2024 over fake military ballots, a

case some lawmakers tried to use to fuel fraud narratives even though it wasn't voter fraud in Wauwatosa [[WPR](#), 3/20/2024] [[Milwaukee Journal Sentinel](#), 5/2/2024].

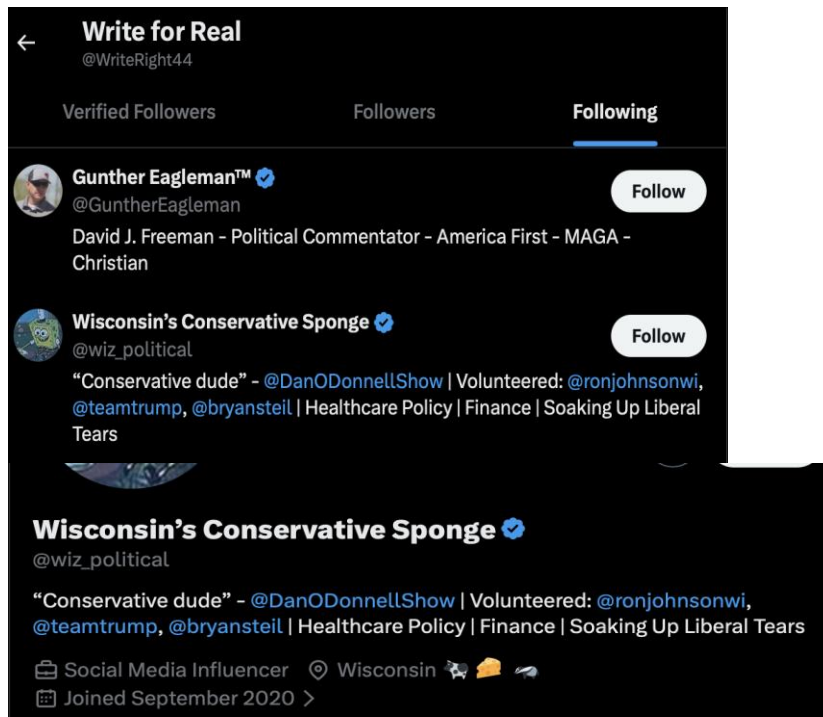

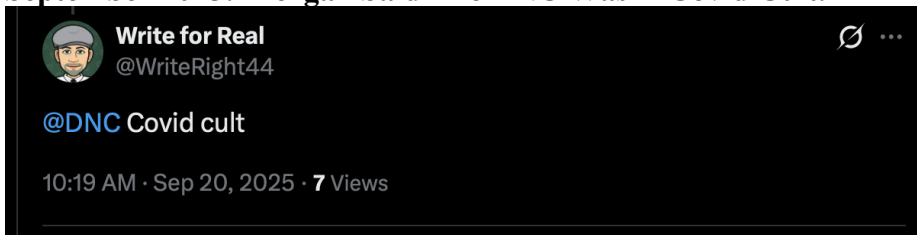
