Midland is a mid-sized city in central Michigan (population ~42,000) and serves as the county seat of Midland County. The region is economically anchored by large employers such as Dow Inc., contributing to a relatively stable, professional-class population with strong ties to manufacturing, engineering, and chemical industries. Politically, Midland County has historically leaned Republican at the federal level, though local elections—especially municipal races—are officially nonpartisan and often center on governance, development, and quality-of-life issues rather than overt partisan conflict.

The Midland City Council consists of five members elected by ward in nonpartisan elections, with the body responsible for local policy, budgeting, and oversight of city administration. Ward-level races can be low-profile and lightly contested, with candidate quality and civic engagement often varying widely. The Ward 5 seat is open following the withdrawal of a long-tenured incumbent, creating an unusually fluid political environment with less institutional continuity. [[Midland News](#), 4/26/2026]

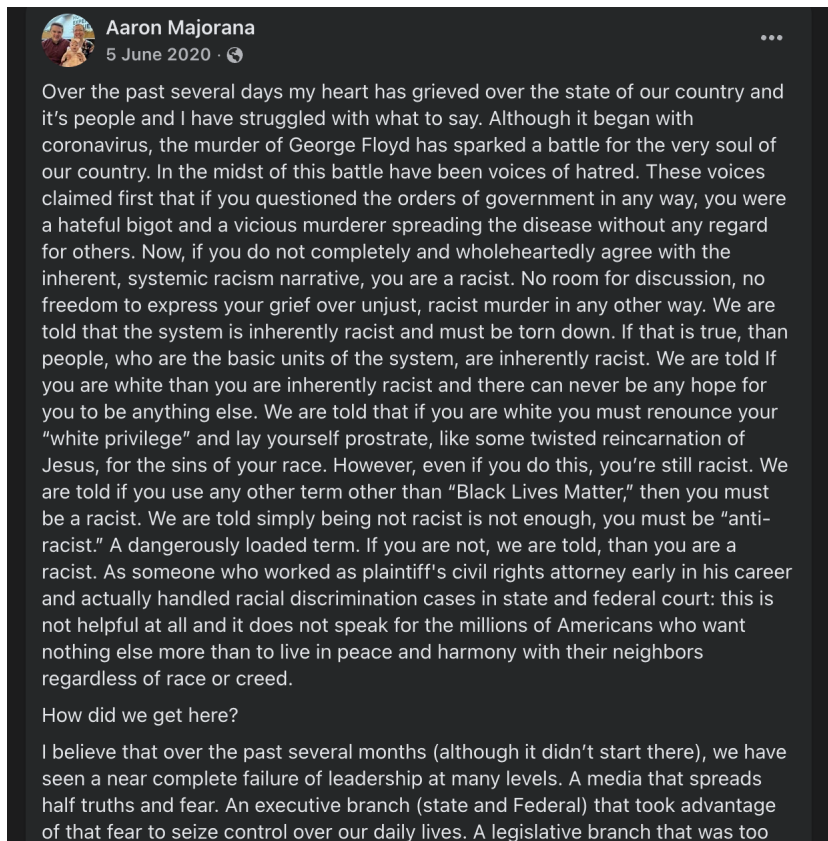

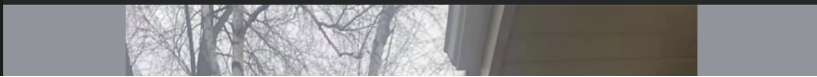

"The only thing we have to fear is fear itself."

Over the past several days, I have seen several posts including a video telling people to stay home and under absolutely no circumstances leave your house for any reason. If they don't do this, we are told, people will somehow die. I have also seen a post somehow connecting hospital visitation rights to whether or not you went to the store. This is nothing less than blatant fear-mongering designed to create panic and it needs to stop.

I believe much of this is related to the term "exponential growth," which was used by the Governor during her announcement of her "Stay Home, Stay Safe" order and has floated around since. To be sure, what we are seeing in the Detroit Metropolitan area (the most densely populated area in Michigan) might be something close to exponential growth but that is not the case everywhere.

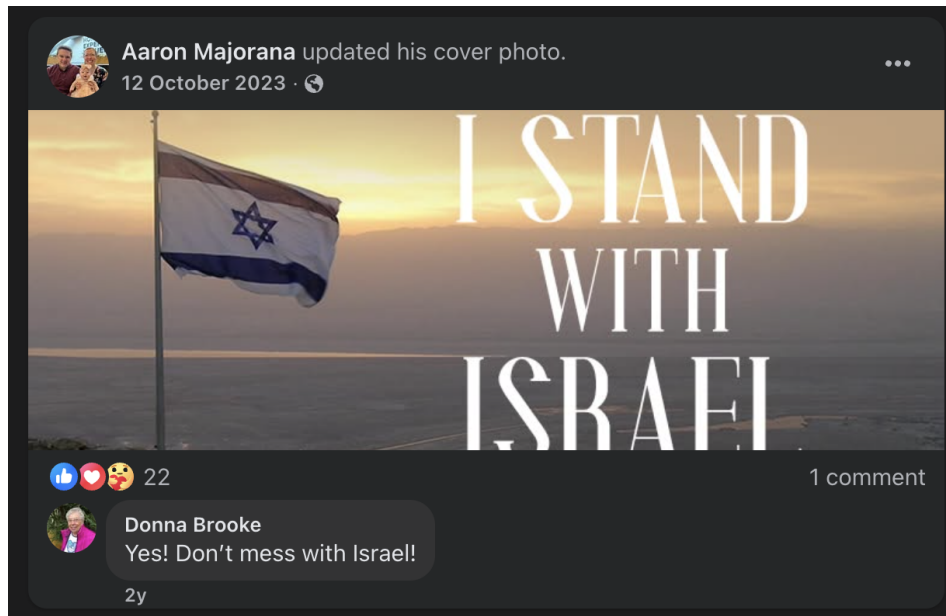
For perspective, consider Saginaw and Midland Counties, where I live and work. As of today, Saginaw County tested 205 residents, 64 negative results, 131 pending results, and only 10 positive cases. This is an increase of 1 case from the previous day, which was an increase of 1 case from the day before that. The first cases in Saginaw County were reported over the weekend of March 20, 2020, starting with 2 and increasing to the current number during the week. While information has not been released on all of these cases, many of them have been reported to be elderly. In Midland, there are 6 confirmed cases with no increases over the last day and none of the reported cases have required hospitalization. The point is that this is not exponential growth.

In response, you might say that I am considering only one data point and I'm comparing apples to oranges compared to places like Detroit or other urban centers. That is true. But the reverse is also true, you cannot extrapolate the numbers presented in places like Detroit and New York over the entire country.

It is also important to remember that most people infected suffer only minor symptoms. (See the CDC website if you don't believe me).
