KEY FINDINGS INCLUDE:

- **No campaign social media.**
- **Very conservative and posts multiple times a day.** Lubinski's personal Facebook has several right wing ideological signals mocking Democrats, spreading COVID conspiracies, criticizing the Obamas, highlighting violent immigrant stories and more.

Garden City is a small suburban city in Wayne County, Michigan, located in the Detroit metropolitan area. It is a working- to middle-class community with a population of roughly 27,000 and a history tied to manufacturing and service-sector employment common across Metro Detroit suburbs. Politically, Wayne County leans strongly Democratic in federal and statewide elections, though many smaller suburbs like Garden City can be more politically mixed, with competitive local races and a mix of Democratic and Republican-leaning voters.

Municipal elections in Garden City are officially nonpartisan, meaning candidates do not run with party labels on the ballot. Local issues typically center on municipal services, fiscal management, zoning/development, and public safety rather than national partisan divides. Election administration and candidate listings are handled at the local clerk level, and detailed candidate information is often limited compared to higher-level races.
