Lee County, North Carolina (anchored by the city of Sanford) is a mid-sized, largely rural-to-exurban county in the Sandhills region. County commissioners serve as the primary governing body, overseeing budgets, taxation, and public services such as health boards and infrastructure.

Politically, Lee County leans Republican at the federal and state legislative levels (e.g., represented by a Republican in the NC House District 51), though local offices are more mixed, with both Democrats and Republicans holding county commissioner seats. The area reflects a blend of working-class, suburbanizing, and rural voters, with local issues (taxes, development, public services) typically more salient than national ideological debates. However, like much of North Carolina, partisan polarization has increased in recent years, especially in down-ballot races.
